### Impact on County Functions

### How Has Responding To The Covid-19 Pandemic Affected County Functions?

- Essential needs i.e. housing/homelessness, solid waste, broadband, transportation, food scarcity, etc.
- Public Safety
- Budget and Finances







#### **Snohomish County**

Early on, Snohomish County identified a need to have better coordination with the human service providers that have been providing resources and outreach to our sheltered population, people working to transition out of homelessness and people experiencing homelessness. Councilmember Dunn organized biweekly calls, collected survey results to identify immediate needs, emerging issues and barriers and complied a stakeholder list of over 80 contacts and organizations. We have weekly updates from the health district, the County and expert speakers on mental health, housing, employment benefits and other identified needs. We've been hearing from the service providers that these calls have been very informative and beneficial for being able to connect with the Health District and Council.

#### **Skagit County**

- Agencies are being creative and flexible with telehealth.
- Our detox has struggled with staffing issues related to COVID and had to cut capacity at different times
- Our outreach workers aren't able to provide transportation.
- Drug court can't do UAs.
- Overdoses have increased.
- People in recovery are struggling due to lack of social support.



### **Land Use and Permitting**

- **San Juan County** has closed campgrounds at all county parks until May 30<sup>th</sup>. The county has also closed all playgrounds, transient rentals (anything less than 30 days) and transient moorage until May 4<sup>th</sup>.
- **Skagit County** has closed its permitting office to the public and most employees are working remotely. Non-emergency building inspections have stopped and any inspections for emergency repairs are being conducted via Facetime or Skype.
- **Island County** has implemented a low-income discount program for solid waste disposal. Transactions are being limited to credit card only cash or checks are prohibited.
- **Snohomish County** has taken action authorizing time limit extensions for permits, applications and other approval. This will provide more time for residents to complete projects and provide information and analysis before their permits and applications expire.



### **Homelessness Resources**



Everett Gospel Mission has reduced capacity by about 50 people and stopped taking in new people to create space and reduce the possible spread of COVID-19. Additionally, they stopped providing congregate meals and switched to sack meals for those who are showing up.



Snohomish County will not be able to continue to shelter the 300 individuals we have gotten off the streets for more than approximately 6 more weeks without an infusion of additional resources.



Snohomish County is interested in grant deadline relief because field crews are not able to get work done on deadlines (mostly federal at this point)



Skagit County has 45 high risk homeless individuals in motel vouchers right now but has no resources to keep these very vulnerable individuals sheltered after May 4

North Sound Region BHASO notes that agencies and facilities are suffering due to the fee for service payment model and BH providers are struggling to survive.
